

# Saluki Age Group Open Water Festival

Saturday, October 3, 2009

Held under sanction of USA Swimming/Ozark LSC #OZ5218

Location: Little Grassy Lake, Camp II Beach

Time: 10:30am start; the water will be open 30 minutes before for warm-ups.

Distance/Event: 11-12 1 mile Boys first, girls start 10 minutes later  
Age Group 13-14 1 mile and a half Boys first, girls 10 minutes later. 15-18 2 mile Boys first, girls 10 minutes later

Open Water Meet Referee: Rick Walker: 618-453-7230

Facilities: Showers and restrooms will be available near the parking area. This is not located right on the beach so swimmers will need to walk to the parking area to use the facilities. Visiting Teams are responsible for fluids and nourishment for their athletes. Emergency response will be on call not on site.

Team Areas: Will be located on the beach. All swimmers are encouraged to leave their valuable in their team areas not in the facilities.

Start and Finish: The start and finish will be from in the water. There will not be a running finish. Results will be based on finish stick first and verified by time second. Upon finish swimmers will walk up to the finish table and turn in their stick and give their name for results. Corresponding times will be added at the conclusion of the event.

Eligibility: Open to currently registered USA Swimming athletes only. "Applied for..." will not be accepted. On deck registration is not available. Swimmers who do not hold current USA Swimming membership will be dropped from the meet. There is a \$100 fine for entering nonregistered athletes in an Ozark meet. Coaches must be currently registered with USA Swimming as Coach members.

Athletes attending the meet unaccompanied by a USA Swimming coach must report to the meet referee or meet director prior to warming up for each session. The athlete will be assigned to a coach on deck for each session of the meet that he is entered.

Entries Fees: \$15 per swimmer – includes surcharge and individual event Charge.
